TEAM LEADER’S FOREWORD

Law and Justice Agencies had once again successfully conducted another roadshow awareness to Community Governments in the 3 Districts of South Bougainville (Buin, Siwai, Bana Districts). The roadshow to South Bougainville is the first of two roadshow inputs for this year.

The aim of delivering this roadshow awareness was to educate people in the communities about the importance of upholding the rule of law as well as to inform them about the available forms of assistance from the respective agencies who were involved. People who were targeted are the youth, women, parents and chiefs in those respective Community Governments and their subsequent wards.

The main messages delivered relate to the importance of upholding the rule of law and the need to respect one another in the society so everyone can enjoy freedom in all aspects.

Social problems in our communities need to be addressed if not minimised through increased awareness efforts by all stakeholder organizations at this time.

Village elders and other authorities at the Ward level have been urged to cooperate to build a connecting role in ensuring that peace and stability is maintained at all times and in preparation for a peaceful conduct of referendum next year in 2019. Every effort taken in upholding the rule of law at the community level will create an atmosphere that is conducive for a free and fair vote as well as a peaceful outcome after the Referendum has been conducted.

I commend the tireless efforts of Agency heads and representatives who were able to set some time aside of their busy work schedules to inform the people of Bougainville about the services that their respective Agencies (law and justice service providers) are providing here in Bougainville. You all had humbly done a tremendous task by delivery during the month of May 2018.

A big thank you also goes to our Development Partner JSS4D for the immense support in funding this roadshow awareness, as well as NZPOL for their support to the BPS CAPs Concept on Bougainville.

1.1) Background

- 1.1.1) The Region continues to face ongoing issues and associated challenges impinging on the rule of law as Bougainville moves through a political, economical and socially complex journey and the law and justice sector as a responsible body in ensuring it better puts together the best coordinates in creating a peaceful society that is conducive for all citizens, investors and visitors.
- 1.1.2) Conducting roadshow awarenesses, is one important package for the law and justice sector in Bougainville apart from other roles associated with the implementation of its Annual Activity plans, as aligned and connected to all its Agency Strategic Plans.
- 1.1.3) In conducting the combined law and justice roadshow awarenesses annually, the sector hopes to bring a uniformed message across to all Bougainvilleans that the rule of law is paramount for a better society to live in and that abuses of all forms including the abuse of alcohol and other illicit substances are detrimental to ensuring and creating peaceful communities to all including South Bougainville.
- 1.1.4) Messages for creating conducive societies at the village level were conveyed to the Community Governments and subsequent ward and village level authorities during the delivery of the roadshow awareness to the 3 Districts of South Bougainville.
- 1.1.5) The recently delivered roadshow awareness is the first input of the two (2) planned roadshows for this year.

1.2) Purpose of Roadshow

- 1.2.1) The purpose of this Community consultative Law & Justice Roadshow through the respective Community Governments as the authorities on the ground, was to inform people in the Communities of South Bougainville about the importance of law and order as a determining factor to promote peace, stability and good order. The message was also echoed to help urge communities in doing away with homebrew and marijuana which are the main causes that trigger violence of all forms in the communities.
- 1.2.2) The Roadshow also carried a message for Community and Village authorities to have a more coordinated role to strengthen and connect their daily activities to address the lawlessness and to create a conducive social environment in their respective communities for all but more for the vulnerable to enjoy.
- 1.2.3) Many people in the communities many of whom have missed passed roadshows do not know of accessible justice services that each respective law and justice agency provides as part of their core functions and it was such an opportunity for them to know such valuable information.

1.3) Rationale

- 1.3.1) The Sector’s conduct of the roadshow is a necessary part of its vision for a just, safe, secure and free Bougainvillean. The Sector strives to achieve this vision by carrying out its mission which “is to provide the best possible law and justice service to the people of Bougainville and their Government (ABG)” through this political transition period. The Sector had identified an important ‘target group’ that needs to be informed of available services, opportunities, and essential information about the consequences of making wrong choices in life which are the young people in the Community Government areas.
- 1.3.2) The key message disseminated by the Team of law and justice agencies was for Community leaders to guide their people to envision a decent future that can only be achieved through a cooperative effort in order to create a conducive environment for them after the referendum is conducted for Bougainville in June 2019 and beyond. The future of Bougainville entirely depends on every guiding authority at the village level and this message was also echoed in the 2017 roadshow to high schools and secondary schools in which the emphasis was on becoming good leaders, parents and citizens.
- 1.3.3) Likewise, conducting ‘awareness roadshows’ is one key outcome area under one of the ABG Department of Police, Corrective Services and Justice’s 6 Outcome Groups (Outcome Group 3 – Coordination of law and justice services) under the ABG Department of Police, Corrective Services & Justice’s Corporate Plan 2017-2019.

1.4) Establishment of the Roadshow

- 1.4.1) The roadshow was an initiative of the Bougainville Law & Justice Sector which implements its Programs and activities through a coordinating body known as the Bougainville Law & Justice Coordinating Mechanism (BLJCM).
- 1.4.2) During its first meeting of 2018 convened on the 7th of March 2018, the ABG law and justice through its BLJCM agreed to deliver the awareness throughout all accessible Districts in the 3 regions of Bougainville beginning with South Bougainville. It was also agreed that an Officer from the ABG’s Department of Peace Agreement Implementation (DPAI) be included in the roadshow team to answer and clarify people’s questions that relate to ‘referendum’ issues at roadshow venues.
- 1.4.3) An Advance Party was sent beforehand to set up the Roadshow with Community Government Chairmans in consultation with the District Managers of Buin, Siwai, and Bana Districts.

- 1.4.4) The advance party's role was to immediately liaise with the respective Community Governments on suitable dates and timings for the conduct of the roadshow awareness.
- 1.4.5) The roadshow showcased Law & Justice agency roles, as well as it also advertised the services that are available through each respective agency.
- 1.4.6) The roadshow initiative was part of the Bougainville Law & Justice sector agencies' responsibility to;

1. Inform people in the communities about each agency's role, the importance of the rule of law as well as the service available and which can be accessed through these agencies.

2. Collect feedback information, through such an awareness as the main approach of community consultative process which allows for adjustments to the Bougainville sector's planning processes in order to be responsive to immediate issues and to be consistent with its (BLJS) own vision and mission statements.

1.5) Conduct of the Roadshow in the three (3) Districts of South Bougainville

- 1.5.1) The Roadshow in South Bougainville was conducted during the month of May in 2018 and it covered all Community Governments in South Bougainville. It was conducted from Monday 27th to Friday 26th of May. It covered seven (7) Community Governments in Buin District, 3 Community Governments in Siawai District and 3 Community Governments in Bana District.
- 1.5.2) The team left Kokopau at 1pm BST and travelled into Arawa and stayed overnight on Sunday 20th of May 2018 and the began the roadshow on the following day at the Wisai Community Government.
- 1.5.3) After completing the roadshow at Wisai, the Team left for the Buin Town Market and began the awareness at 2:30pm BST to listeners of both Baubake and Lugakei Community Governments.
- 1.5.4) After conducting the roadshow at the Buin town market, the Team then retreated to the Buin to rest for the night.
- 1.5.5) All heads of Agencies were not able to attend to this week-long awareness due to commitments beyond their control as well as the fitness travel on long bumpy dirt road networks in South Bougainville.
- 1.5.6) The Agencies did their presentations following the 'Justice Track or the Justice process/cycle and in the following order:

1. An overview/Introduction by the Team Leader Mr Kearnneth Nanei, 2. Police (BPS), 3. Magisterial Services (MS), 4. National Judicial Staff Services (NJSS), 5. Public Solicitor's Office (PSO), 6. Community Based Corrections (CBC), 7. Correctional Services (CS), 8. Village Courts & Land Mediations (VC&LM), 9. Ombudsman Commission (OC) and 10. the ABG's CommDev-Family Sexual Violence section (FSV).

- 1.5.7) After all presentations by the Agencies at every location, time was given for people in the communities to ask questions regarding issues to any agency they might have questions to.
- 1.5.8) The only Agency which did not take part during the roadshow was the Office of Public Prosecutor as there is still a vacancy after an Officer left for other employment opportunities outside Bougainville. However, questions raised in relation to the OPP's role were answered by related agencies who attended such as the Courts.
- 1.5.9) Feedback given by mostly community leaders during the roadshow indicated that there was still a need for the sector to continue staging their awareness further into the remote areas into certain areas since people in those areas do not or can't make it to central locations due to distance and lack of transport.
- 1.5.10) Communities were informed about the importance of the rule of law and the roles of each of law & justice agency that is established in Bougainville. This information which also included the services that people can access through these agencies.
- 1.5.11) Included in the team, was an ABG Department of Peace Agreement Implementation representative who presented on matters regarding to Referendum as well as of confusion with it as a process whilst 'independence' is one of the outcomes of two or more possible outcomes of questions to be put on the ballot in 2019.
- 1.5.12) The law and justice team conducted the roadshow awareness to the following Governments:
- Wisai Community Government
 - Baubake & Lugakei Community Governments combined
 - Konnou Community Government
 - Tonolei Community Government
 - Lenoke Community Government
 - Makis Community Government
 - Ramu & Kopii Community Governments combined
 - Motuna/Huyono Community Government
 - Lato Community Government

- Bolave Community Government

1.5.13) The only Community Government area which the team did not conduct the roadshow was the Baba Community Government in the Bana District as there was still an ongoing unsolved clan dispute between two parties.

1.6) Outcome of the Roadshow in the three (3) Districts of South Bougainville

1.6.1) The total estimated number of people (attendees) who attended to the awareness roadshow in the respective roadshow locations visited was 1090 heads.

1.6.2) The following is an estimates number of heads for each of the Community Government venue visited:

- 1) Wisai CG = 40 heads,
- 2) Baubake/Lugakei CGs = 60 heads,
- 3) Konnou CG = 30 heads,
- 4) Tonolei CG = 130 heads,
- 5) Lenoke CG = 30 heads,
- 6) Makis CG = 600 heads,
- 7) Kopii/Ramu CGs = 30 heads,
- 8) Motuna Huyono CG = 60 heads,
- 9) Baba CG = cancelled
- 10) Lato CG = 30 heads,
- 11) Bolave CG = 40 heads.

1.6.3) The roadshow as conducted by the law & justice agencies to Community Governments in the three (3) Districts of South was led and coordinated by the Department of Police, Corrective Services and Justice. The agencies informed people in the communities about the importance of the rule of law in protecting people lives and properties compared to the insecurities of factionalism without the rule of law. The agencies also talked to the people about their core functions, the services they provide and which can be accessed by people.

4. PERCEPTION SURVEY ON COMMUNITY

A perception survey was carried out during the course of the roadshow awareness to Community Governments. The Survey covered an estimated population of more than 1090 heads from the Community Governments in South Bougainville.

4.1) Survey Objective

4.1.1) The Bougainville Law & Justice Sector conduct this survey with a general objective of getting feedback impressions from people's perceptions about the general impact of law, order, justice situations at the Community level. The survey was conducted to both the male and female genders in the respective communities covered.

4.1.2) The survey was aimed at achieving the following;

- 1) People by now should upholding the rule of law as the foundation for other developments that will determine the building of a strong political, economic and social future. The people of Bougainville should be encouraged to uphold the rule of law, as much as to respect the course of justice in order for a better Bougainville to live in.
- 2) That the village level Community Government is the ultimate authority to lead the way in addressing social problems as a result of drug and 'home brewed' alcohol abuse in the communities. This is crucially urgent step in preparation for the 'Referendum' and its outcomes in 2019.
- 3) This basic survey can also provide the basis and catalyst for cost-effective researches that hopeful undertakers (any stake holder) may want to or intend to carry out a region-wide feedback consultation on issues relating to law and order and human rights violations.
- 4) An encouragement for young people to live a decent life that will set the foundation for a better generation of law abiding people who will manage their own lives independently and through hard work.

4.2) The Conduct of Survey

- 4.2.1) The survey was conducted on law and order and the status of human rights abuse, as well as the threats in the communities. This feedback survey was focused on people's impressions on the work of the Bougainville Police Service, the Community Auxiliary Police concept and the work of village courts.
- 4.2.2) The survey was conducted by way of random selection of a people who attended the roadshow. 30 literate respondents (15 males and 15 females) representing their respective Community Government populations were handpicked to answer the team's questionnaire that was provided at each venue.
- 4.2.3) The reason why only 30 respondents were selected to answer the questions on behalf of their respective Community Government populations was not only due to time limitations given at each venue but also because of the immense task of putting responses against questions and response options in both table and graph expressions for all who attended the roadshow.
- 4.2.4) A single sheet Questionnaire containing six (6) questions was distributed to the respondents. The six summary questions basically summarized the impact of both law and justice services as measured against the outcomes of service providers who continuously strive to address law and order issues in Bougainville over the past few years.

4.3) The 9 Community Governments Covered by the Survey

- 4.3.1) A total of 9 Community Governments were covered under the survey. These nine Community Governments are Wisai Community Government, Baubake & Lugakei Community Governments combined, Tonolei Community Government, Lenoke Community Government, Makis Community Government, Ramu & Kopii Community Governments combined, Motuna/Huyono Community Government, Lato Community Government and Bolave Community Government.
- 4.3.2) Konnou Community Government in Buin District and Baba Community Government in Bana District were not covered in the survey due to conflicts that were current during the roadshow period. Konnou had a very serious outstanding leadership issue that needs political intervention while Baba had a law and order issue that was still being sorted and mediated by the BPS for the arrest of certain suspects.
- 4.3.2) The survey results for each of the 9 Community Governments covered were put into tables and illustrative graphs. The table survey results are contained in the

Appendices which include accompanying graph illustrations that can be found at the back of this report.

4.4) Issues Raised through Questions

- 4.4.1) During the course of the awareness, people in the respective Community Governments of South Bougainville were given an opportunity to ask questions after all presentation were done by the Agencies.
- 4.4.2) All Questions asked by people were taken note of. Out of these questions, issues were identified and listed by way of a 'Summary Action Plan' which calls for further action to be taken by each Agency responsible.

5. SUMMARY OF REPORT

As part of its Objectives that are contained in its Mid-Term Development Plan 2016-2019, the BLJS had initiated to conduct this awareness program to the Community Governments around the Autonomous Region of Bougainville. The Roadshow awareness was executed during the month of May 2018.

5.1) The Agencies

- 5.1.1) A total of 9 (Nine) Agencies within the Sector took part in this roadshow and they are: ***Police (BPS), Correctional Services (CS), Public Solicitor's Office (PSO), National Judicial Staff Services (NJSS), Magisterial Services (MS), Community Based Corrections (CBC), Village Courts & Land Mediations (VC&LM), Ombudsman Commission (OC) and the ABG's CommDev-Family Sexual Violence section (FSV).***
- 5.1.2) The purpose of this awareness roadshow was to inform people in the communities about each law and justice agency's core functions and roles, as well as the services provided by the agencies that can be accessed when seeking legal or protection from abuse and continued violence.
- 5.1.3) The intention of the awareness roadshow was to educate people in the communities through their Community Government authority structures about

the different functions of the agencies within the law and justice sector in Bougainville. Moreover, the whole idea was also to bring a strong message about the importance of the rule of law across all communities, as well as to encourage everyone especially young people to refrain from getting themselves involved in activities that will destroy their current livelihoods and which will prevent them from working towards a brighter future. These activities include the abuse of home brewed alcohol and marijuana consumption which is the common problem among young people and many adults right across the Region.

- 5.1.4) People were encouraged to become law abiding citizens for Bougainville if Bougainville is to enjoy peace and good order at a time when the Region is preparing itself for the coming Referendum in 2019 and the times beyond.
- 5.1.5) The Agencies also distributed information brochures and leaflets during presentations. This included a general information leaflet explaining the role of each agency.
- 5.1.6) As part of its expected feedback, the BLJS Team also conducted a survey on 30 randomly selected people at the respective community roadshow venues. This initiative was done by way of distributing 30 questionnaires each containing 6 questions relating to people's perceptions on the work of law enforcement and policing services, as well as the work of village courts and the measure of the general impact of law and justice agencies in Bougainville.
- 5.1.7) The survey also tried to identify whether there has been any improvement on the impact of the delivery of law and justice services.

5.2) Survey Questionnaire

5.2.1) The Six (6) Questions as they appear in the Survey Questionnaire are:

1. What do you think about the role of the Bougainville Police Service in Bougainville?
2. What do you think about the role the Community Auxillary Police (CAPs) in your Communities?
3. What do you think about the role of Village Courts in Bougainville?
4. Is there any improvement in Law & Order in Bougainville over the last 2 Years?
5. What is your opinion about Home brew & Marijuana consumption in Bougainville?
6. What do you think about the prevalence of Sorcery in your community and Bougainville?

5.2.2) These six (6) Questions and their responses are summarized within the Table Appendices and Illustrative Graphs attached at the end of this.

5.3) Summary of Findings

Through the survey conducted, the BLJS realised that there is quite an appreciation for the work of agencies such as the BPS and Village Courts/Land Mediation, compared to the certain criticisms received from people.

- 5.3.1) The findings indicate that people in South Bougainville do admit that the consumption of 'homebrew and marijuana' is very high in their Community Government areas.
- 5.3.2) And on the other hand, what was thought to be inaction and lack of competence by the law enforcing agency (BPS) as the main reason is not so and is defeated by a significant people trust on law enforcement and community as indicated by the table of results and the illustrative graphs as per the survey results (attachments).
- 5.3.3) As generally indicated across the Community Governments surveyed, people still think that the enforcement of law by the (BPS) which includes the CAPs in the current capacity is performing its functions well except for some disciplinary issues.
- 5.3.4) Moreover, people also have confidence in the work of village courts in the AROB as shown through the survey conducted.
- 5.3.5) There is also an indication across Community Government areas covered that there has been a bit of improvement for general law and order in Bougainville over the last 2 years.
- 5.3.6) Survey findings show that the prevalence of 'homebrew and marijuana consumption' is still the most significant issue which is a 'stumbling block' and continues to affect other efforts in trying to secure a peaceful environment at the community level.
- 5.3.7) This continues to show that the real problem in the Region still is the unprecedented levels of 'homebrew and marijuana' consumption even though the work of BPS Community Policing and its awareness programs have been and are still being executed very well.
- 5.3.8) The prevalence and the continuing high levels of 'homebrew and marijuana' consumption has come to show that there is lack of leadership at the village level where chiefs and parents have either compromised their positions of trust or have simply ignored and allowed this to happen.

5.3.9) The Table below illustrates and confirms the above findings as shown in the Survey Table Results and Graph Illustrations at the back of this Report;

6) RECOMMENDATIONS

- 5.5.1) That awarenesses covering very large areas with scattered village communities such as in the respected Community Governments be conducted individually in a single day and not half a day.
- 5.5.2) That the role of conducting roadshow awareness be given to the more specific relevant Committee which is Juvenile Justice Committee to instil a direct impact message to the youthful population whose troubles it tries to address.
- 5.5.3) This Committee approach can also be seen as a direct deterrent to the foreseen dilemma of maintaining and improving the rule of law which is currently futile during and after the conduct of Referendum, encouraging future overcrowding of the rehabilitation centres and any future major prisons in Bougainville.
- 5.5.3) That other activities not related to the roadshow should not be entertained at any venues as well as community roadshow venues.
- 5.5.5) That a Policy is immediately considered for the ABG to further consider a legislation to establish a Curriculum that will incorporate the 'Law & Justice Track' or 'Justice Cycle' in the high schools and secondary schools' syllabus for Bougainville.

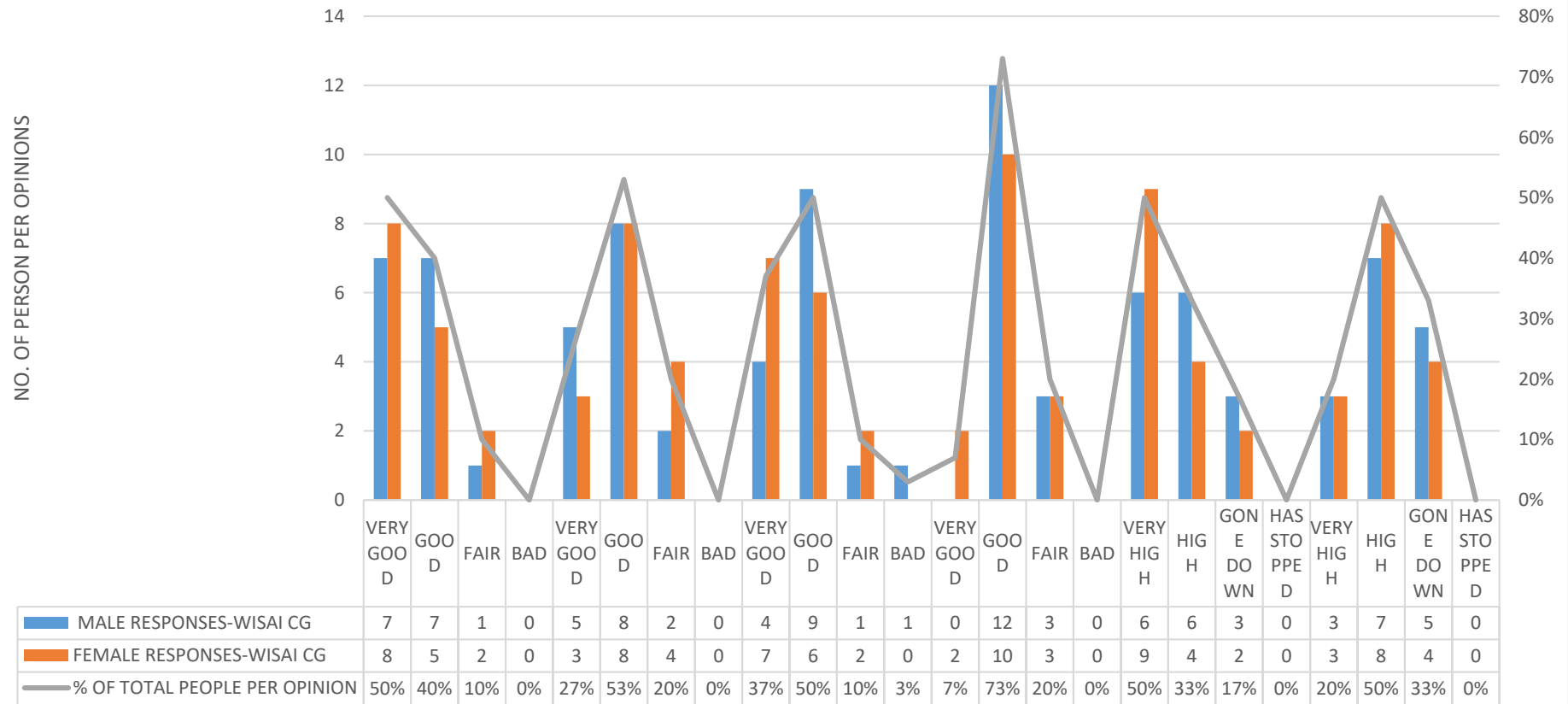


FIGURE 2: TABLE SHOWING BAUBAKE/LUGAKEI COMMUNITY GOVERNMENT SURVEY RESPONSES

ILLUSTRATION 2: SURVEY FOR BAUBAKE/LUGAKEI COMMUNITY GOVERNMENTS - MAY 2018

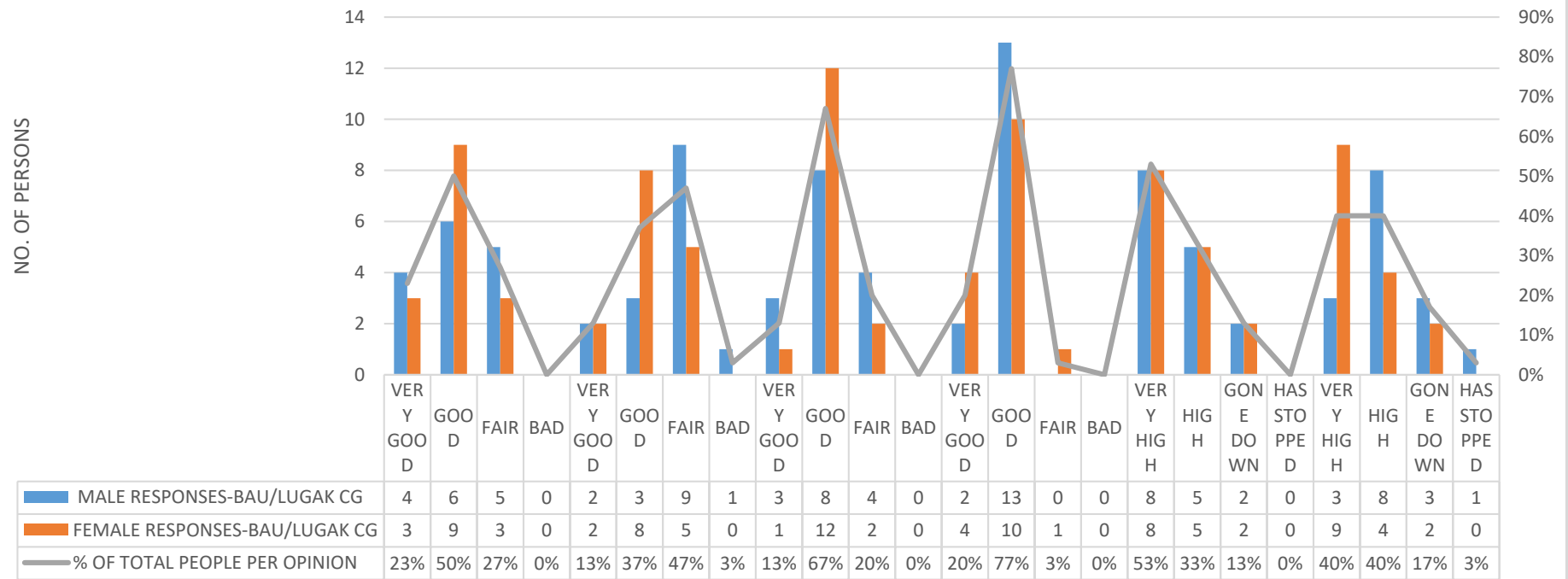
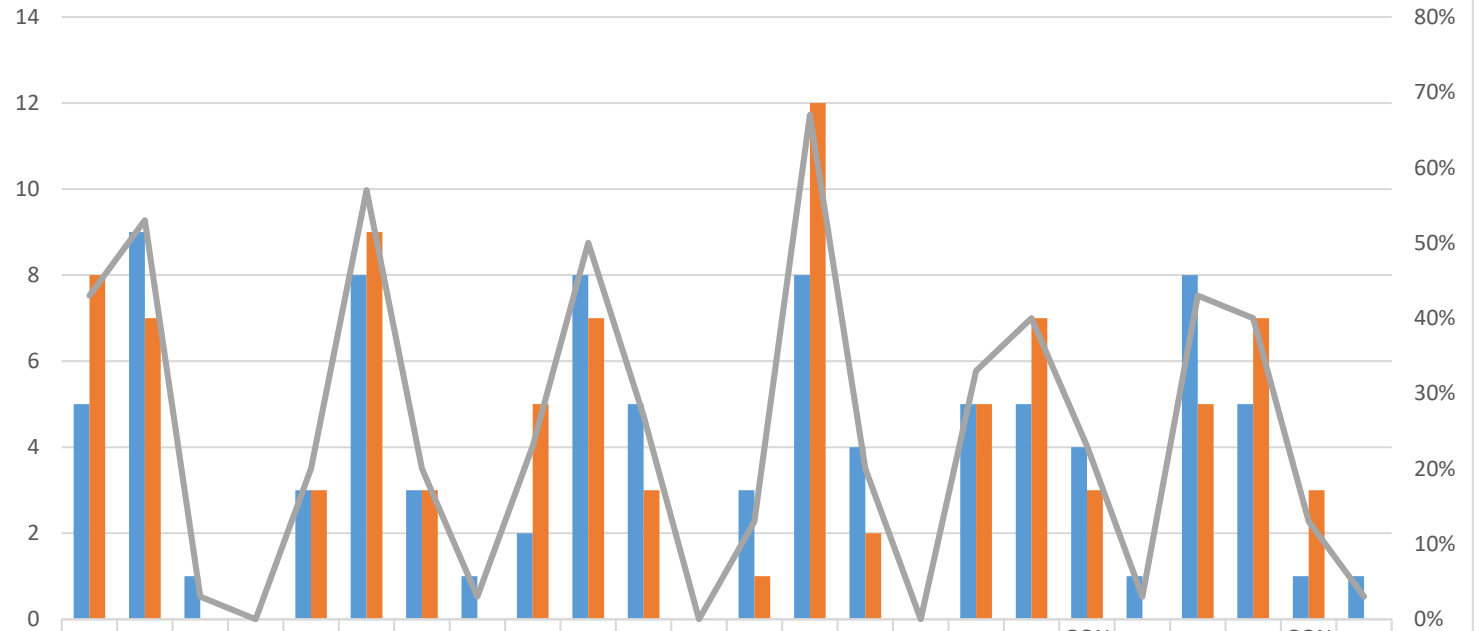


FIGURE 3: TABLE SHOWING TONOLEI COMMUNITY GOVERNMENT SURVEY RESPONSES

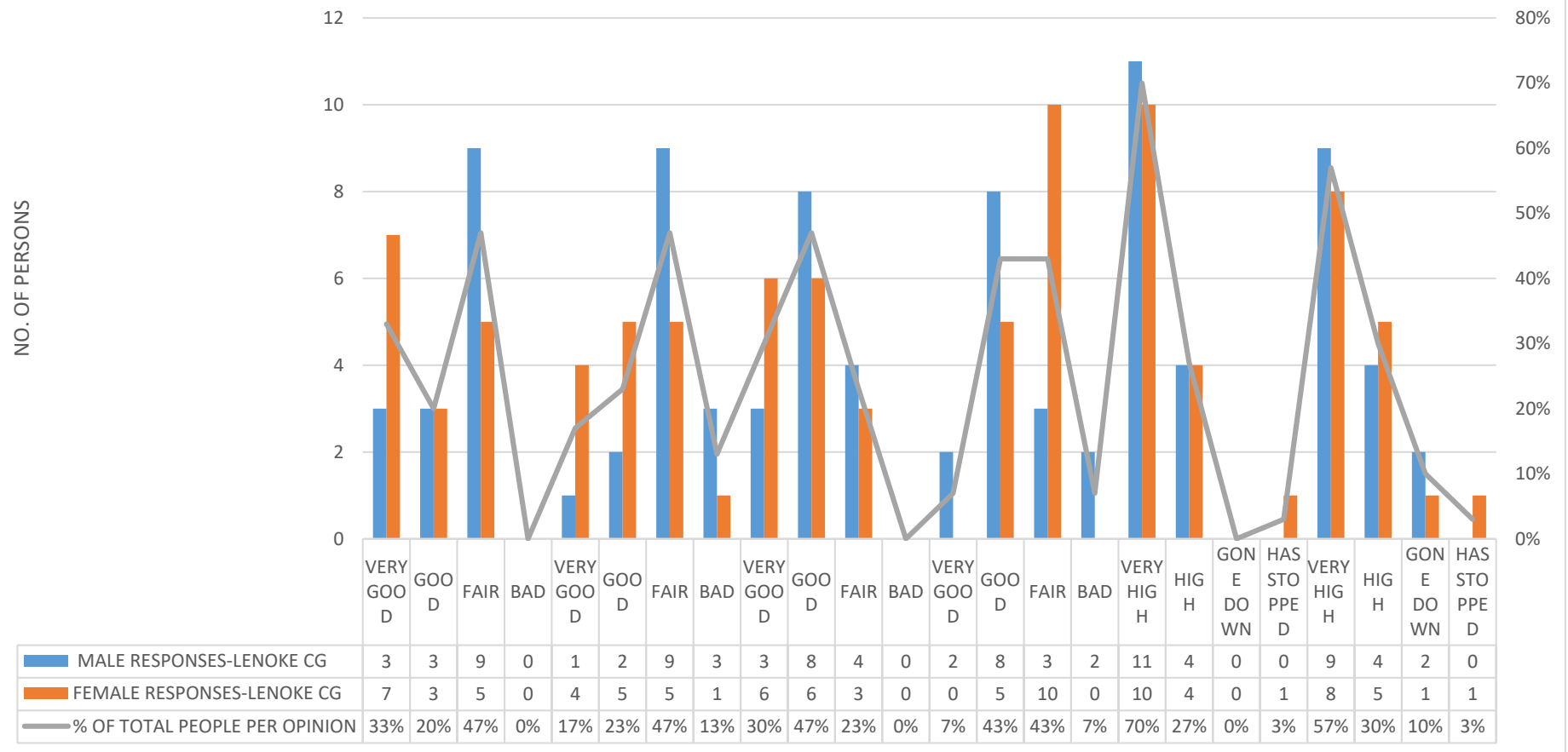


FIGURE 5: TABLE SHOWING MAKIS COMMUNITY GOVERNMENT SURVEY RESPONSES

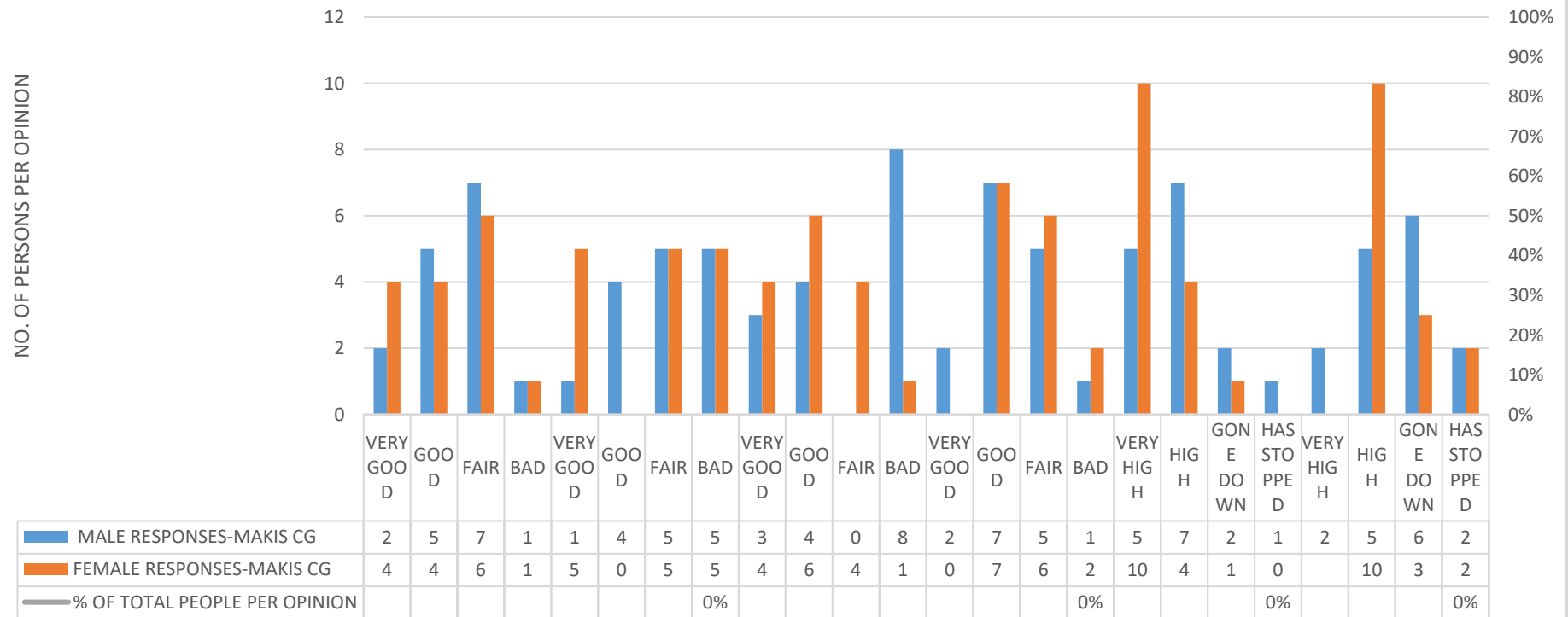


FIGURE 7: TABLE SHOWING KOPII/RAMU COMMUNITY GOVERNMENT SURVEY RESPONSES

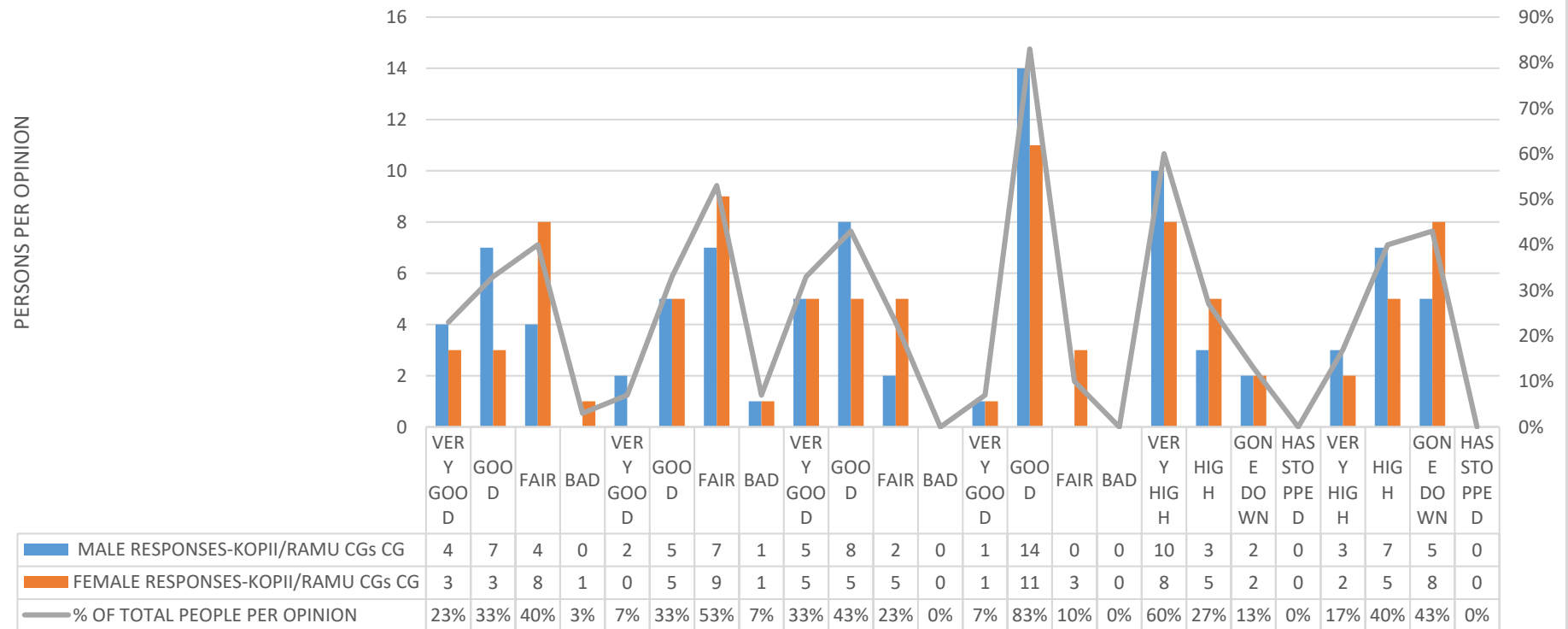


FIGURE 8: TABLE SHOWING MOTUNA HUYONO COMMUNITY GOVERNMENT SURVEY RESPONSES

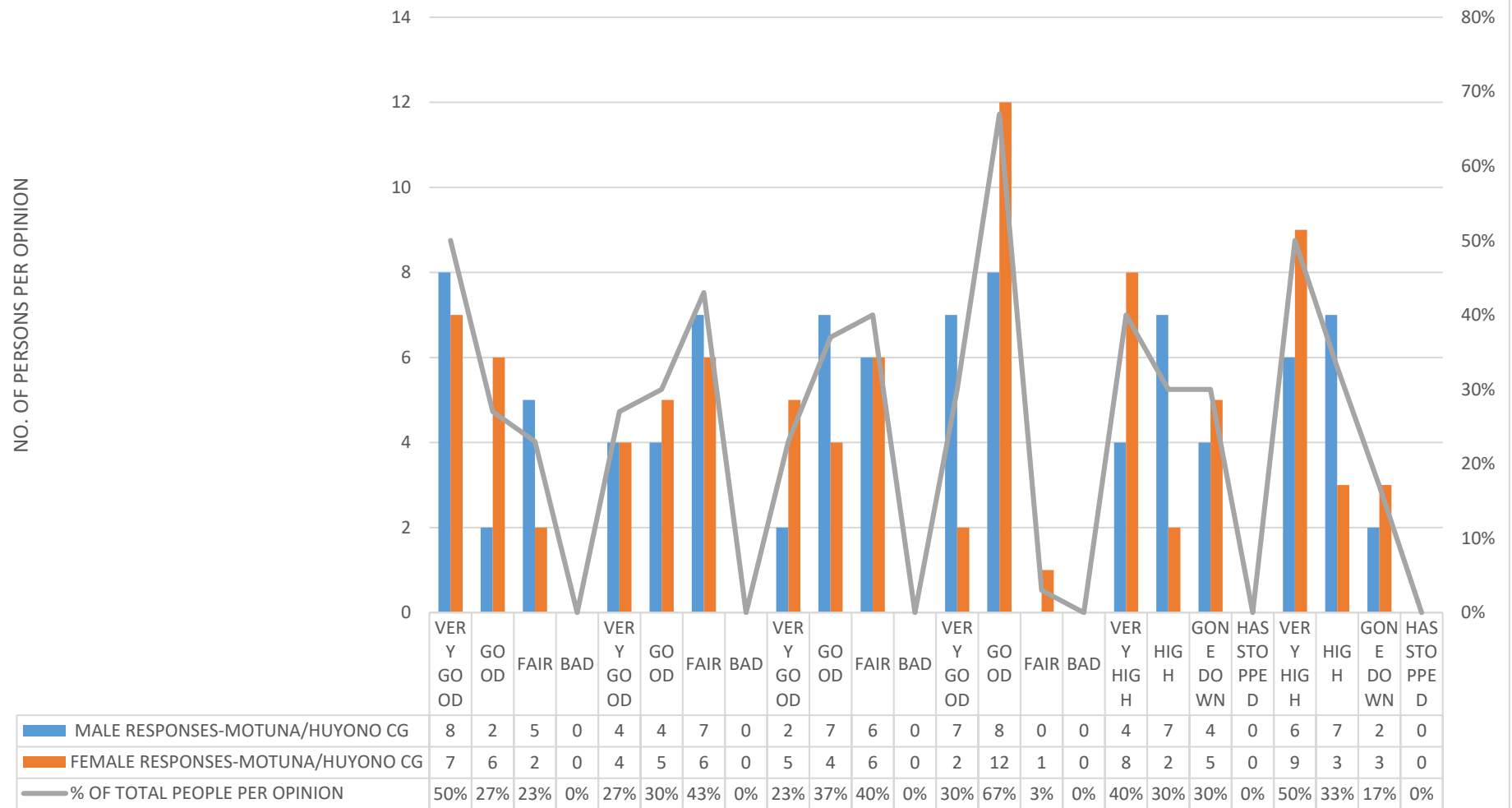


FIGURE 9: TABLE SHOWING LATO COMMUNITY GOVERNMENT SURVEY RESPONSES

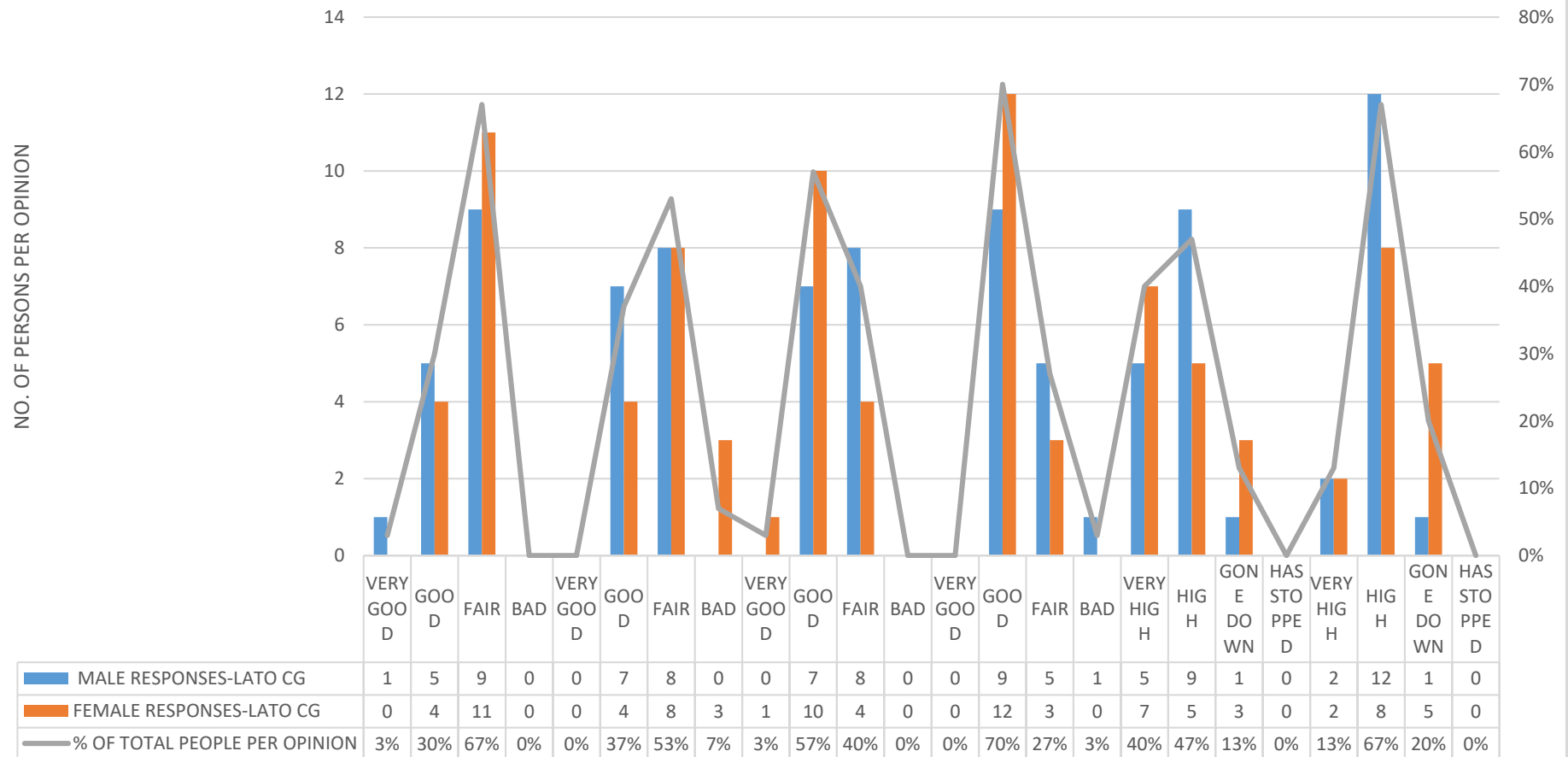
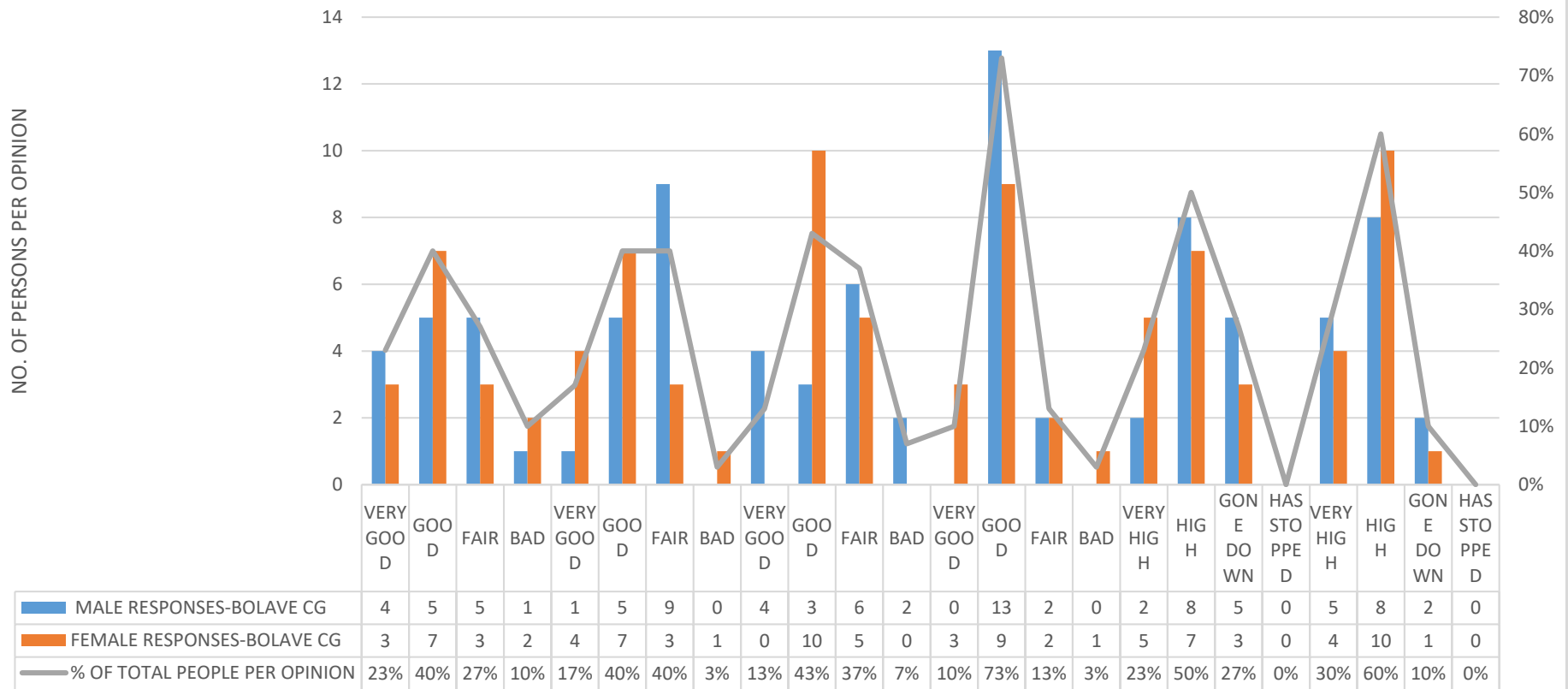


FIGURE 10: TABLE SHOWING BOLAVE COMMUNITY GOVERNMENT SURVEY RESPONSES
