**AN ACT**

***Bougainville Restoration and Development Authority (Repeal) Act 2012,***

Being an Act to repeal the *Bougainville Restoration and Development Authority Act 2006,*

**MADE** by the Bougainville House of Representatives.

**1. COMMENCEMENT.**

This Act shall come into operation on the date it is published in the Bougainville Gazette.

**2. REPEAL.**

- (1) The *Bougainville Restoration and Development Authority Act 2006* is repealed.
- (2) On the date of commencement of this Act all assets and liabilities of the Bougainville Restoration and Development Authority are transferred to the Autonomous Bougainville Government.
- (3) For the purpose of this Section "assets" means property of any kind whether tangible or intangible, real or personal, corporal or incorporeal and without limiting the foregoing includes:-
  - (a) choses in action and money;
  - (b) goodwill; and
  - (c) rights, interests and claims of every kind, whether arising from accruing under or created or evidenced by or by the subject of an instrument or otherwise and whether liquid or unliquid, actual, contingent or prospective.
- (4) On the commencement of this Act the employment of the employees of the Restoration and Development Authority ceases.


