

SFAS 2023 Application Form B2 – TVET

This application form is for institutions that provide TVET Courses in Bougainville only.

The following is a guideline on how to fill in each section of the application form:

Section A

1. This is for **Ministerial use only**.

2. When you submit your application form, an officer from the Ministry of Education will complete this section.

Section **B**

- 1. This checklist determines whether you have fulfilled all the requirements of submitting a complete form to be eligible for selection.
- 2. A registry of the students and the tuition fee structure must be attached to the completed application form.
- 3. Your institution must be verified by the ABG Department of Education in *Section E* of the application.
- 4. If your institution is unable to provide any of the required attachments, please make sure that you have genuine reasons as to why, so that your application can be considered for selection. If there is not enough space on the form to write, you can attach a letter that outlines your reasons.

Section C

- 1. It is important that you fill in all the institutions details to ensure your data is captured and registered accurately in the SFAS Registry.
- 2. It is vital that you provide contact information for the institution, so that the Ministry of Education is able to keep you updated on the progress of your application.
- 3. For reference, *Region* refers to whether the institution is located in North, Central or South Bougainville.

Section D

1. Apart from filling in this section, you must also attach the tuition fee structure where you outline the fees charged and what these costs cover.

- 2. The *Total tuition cost (Annual)* refers to the total sum of tuition for all the selected students for the entire year.
- 3. If your institution is being assisted through other government schemes, it is important to provide that information.

Section E

- 1. This section is for the ABG Department of Education through their TVET Officer, to verify your institution as being a recognised TVET institution in Bougainville.
- 2. The department must sign and stamp this section.
- 3. If you prefer, you may attach a verification letter from the department instead of filling out this section.

Section F and G

- 1. Please read and understand the terms and conditions before you sign the agreement on behalf of the institution.
- 2. In the Statement of Agreement, the authority, signing on behalf of the institution, must write their name, position, sign, and date. It should also be stamped as proof of legitimacy.

Section F

TERMS AND CONDITIONS

Part 1 – Payment of Fees:

- a) The Autonomous Bougainville Government is only responsible for paying 60% of the total tuition cost for selected students
- b) It is the responsibility of the students parent/guardian to pay the remaining 40%
- c) The student's parent/guardian must guarantee that 40% will be paid in full before ABG pays the 60% SFAS component
- d) Institutions must ensure that the parents or guardians of students under this school fee assistance scheme are only charged 40% of total tuition.
- e) Institutions are responsible for providing a receipt of payment from their school administrations to the Ministry of Education
- f) If the parents or guardians of selected students opt to pay the full amount due to long waiting period for ABG School Fee Assistance, the institution must contact the Ministry to advise the office
- g) The selected student is not entitled to reimbursement of fees if he/she chooses to pay the full tuition cost (due to long waiting period from ABG).
- h) The institution must provide list of students withdrawn due to non-payment of fees

Part 2 – Civic Duties and Social Obligations:

As an Institute of TVET Education operating in the Autonomous Region of Bougainville, ABG requires that the school provide updates about the progress of the institution and supported students'

The Ministry of Education will monitor and track the academic performance, social responsibilities and community engagement of supported students and institutions to ensure that terms and conditions are met, during and after the completion of students' studies. This is in line with ABG's political timeline for independence readiness.

The institution must ensure that they will maintain a relationship with the Ministry of Education, and provide regular updates in line with the terms and conditions.
